

New Priority Mail Packaging Products

Currently, there are three standard Priority Mail packaging products:

- Flat Rate Cardboard Envelope (9"x12")
- Tyvek® Envelope (12"x15.5")
- Cardboard Box (12.5"x15.5"x3")

In response to customer demand, the Postal Service has developed three new package sizes. These products, which are described below, will be available to customers beginning June 17, 1996, in addition to the standard boxes described above.

The new products are:

- Video Box (8.5"x5"x1.5")PSIN 01096 PSN 8115-03-000-7007
- Medium Box (11.5"x2.5"x14")PSIN 01097 PSN 8115-03-000-7008
- Triangular Tube (38"x6")PSIN 01098 PSN 8115-03-000-7009

The new tube will replace the current Express Mail tube (which is two inches shorter-PSIN 01094) as current supplies are exhausted, and will then be used for both Express Mail and Priority Mail.

On May 27, samples of the new packaging products will be sent to Postal Business Center managers, national account managers, senior account represen-

tatives and account representatives. A standup talk and other communications materials are available from area corporate relations centers.



As the U.S. Postal Service approaches its 25th anniversary on July 1, 1996, there are many opportunities to enhance the stature of the Postal Service while building spirit and pride among its 753,000-member family.

The Postal Reorganization Act of 1970 was signed into law in August 1970 by President Richard Nixon, and became effective July 1, 1971. The creation of the U.S. Postal Service marked a milestone in the nation's postal system, a departure from the political bureaucracy of the past. It became an independent establishment of the government, dedicated to providing efficient and effective service to the American public.

The 25th anniversary of the Postal Reorganization Act of 1970 will be marked by a series of events at post offices throughout the country designed to enhance public awareness of the Postal Service and reaffirm its association with people in small and large towns across the nation. Local programs will be built around many activities.

A 25th anniversary celebration, whether it's at a post office, a postal station, or a processing distribution center, offers a way to educate the public about the highlights and history of our Postal Service culture. Opportunities should be sought to demonstrate the progress that has led to our present technology-age environment, while also recognizing those employees who have performed admirably to position the U.S. Postal Service as an effective and efficient organization.

A key element of the 25th anniversary includes the widespread hosting of celebrations on July 1, 1996, at postal facilities throughout the country. Postmasters are encouraged to develop programs that invite participation from their employees and provide recognition for their employees and families. Postmasters may wish to sponsor local activities throughout the month of June leading up to the anniversary.

To assist you with local programs for this occasion, this guide contains step-by-step instructions for planning and conducting activities. Included in the package is information geared toward large post offices and also to those smaller offices that may want to host similar events on a smaller scale.

Recognition ceremonies for employees whose careers span the past 50 years should be built into your local program. Special 50-year certificates bearing the signature of the Postmaster General will be designed for presentation to those employees having 50 years or more of actual Postal Service employment as of July 1, 1996. You will need to advise your Area Corporate Relations Center of the names of these special employees. You also are encouraged to present 25-year pins to those employees who will have achieved 25 years of service in 1996.

Externally, our 25th anniversary messages will be woven into major speaking platforms, including the progress in all areas from automation to service. The growth and development theme will be positioned through speeches, external story placements and media interviews.

BACKGROUND INFORMATION

25TH Anniversary of the U.S. Postal Service

uly 1, 1996, is the 25th anniversary of the U.S. Postal Service, which began operations on July 1, 1971, replacing the Post Office Department.

Postal reorganization, born of the crisis created by years of neglect of the nation's postal system, has enabled the system to modernize and cope with the burgeoning growth of the nation and of mail volume in the last three decades.

It is one of the most significant events in the history of the nation's postal system, which dates to 1775, when the Continental Congress chose Benjamin Franklin as the first Postmaster General of a group of colonies in revolution against England and struggling to become a nation.

The nation's postal system is intertwined with the robust growth and expansion of the nation across the North American continent in the 19th century. Literally, it grew up with the nation. The post office was one of the public institutions that Americans depended on as western expansion moved across the continent. Despite the rise of competition and growth of new communications technologies in the past quarter century, the nation's postal system continues as one of the indispensable links for personal and business communications.

Binding Our Nation Together

Soon after the adoption of the Constitution in 1789, the office of Postmaster General was created. President George Washington named Samuel Osgood as the first Postmaster General under the Constitution. There were 75 post offices and about 2,000 miles of post roads. In addition to the PMG, there were three surveyors, a secretary/comptroller, one inspector of dead letters, and 26 post riders. When the national government moved from Philadelphia to Washington, D.C. in 1790, all the department's records, furniture and supplies fit into two wagons.

As the nation grew, the post office helped to bind it together. In isolated communities and on farms and ranches, one of the few links with the world was through mail, and newspapers delivered by mail. Post offices, along with the railroad, helped put towns on the map.

Technology was used from the first to help move the mail. Postal officials, occasionally enduring public ridicule and embarrassment, experimented with delivering mail by foot, horseback, stagecoach, on steamboats plying the great rivers, in railroads, automobiles and trucks and into the air age in the cargo holds of airplanes. There also were less successful attempts to transport mail via balloons and helicopters. The Pony Express, symbolizing one of the most romantic episodes in America's pioneer history, operated as a private enterprise and later under contract as a mail route from 1860-1861. It could deliver a letter from St. Joseph, Missouri, to Sacramento, California, in 10 days, less than half the time of the overland stagecoach. The coming of the transcontinental telegraph line sent the Pony Express galloping into history after only 19 months of operation.

Customer Needs

Intil 1851, the cost of sending a single sheet letter 40 miles was either six or eight cents. When the letter traveled more than 400 miles, postage was 25 cents. Prices doubled, tripled or quadrupled with each additional sheet. The sender had to take the letter to the post office, and the addressee had to pick it up unless he or she lived in one of 40 big cities where a carrier would deliver it to the address for an extra penny or two. Letters could be sent without postage until 1855, when prepayment became compulsory. Street collection boxes began to appear in large cities in 1858, and free city delivery started in 49 of the nation's largest cities in 1863.

But country cousins had to wait until 1896 when rural free delivery (RFD) began in West Virginia. Critics fought RFD, claiming it would cost too much to deliver mail over rutted roads and through thick forests. Since a prerequisite for rural delivery was improved roads, a byproduct of the new service was the extension and improvement of existing roads. Farmers and rural residents were delighted with RFD. In Indiana, farmers in one county paid \$2,600 to grade and gravel a road in order to qualify for delivery. RFD was a cultural, economic and social agent, too, drawing industrial and rural America closer together.

So from the beginning, the post office developed a strong tradition of responding to changing customer needs. As the nation grew, the postal system grew and adapted.

Tremendous increases in mail volume, the revolution in transportation and the rise in the cost of collecting, processing and delivering mail helped produce the ZIP Code. Introduced in July 1963, a five-digit code was assigned to every address in the nation. While not mandatory, the public and large mailers alike used the code. It was the bedrock upon which the mechanization, and later the automation, of mail processing was built.

It became increasingly apparent in the late 1960s that the Post Office Department was in deep trouble. Years of financial neglect, lack of capital investments and decades of political influence over operations and appointments of employees and managers caused the postal crisis. Large subsidies kept rates artificially low. Employees had limited career opportunities, many spending entire careers in the same position. A lack of modern equipment to handle growing mail volume and antiquated facilities contributed to deterioration.

Chicago Logiam

In 1966, the Chicago Post Office ground to a halt under a logjam of mail. Congressional hearings brought out the fact that the Postmaster General had almost a total lack of control over postal rates, transportation, facilities, conditions and levels of service, and employee compensation. Except for the ZIP Code, mail, for the most part, was being handled in the same way it had been handled 100 years earlier, despite skyrocketing mail volume. A brief postal strike in 1970 served to galvanize the forces necessary to address the problems, which led to the Postal Reorganization Act (PRA) of 1970, creating the Postal Service.

The law made the new U.S. Postal Service an independent establishment of the executive branch of government with the goal of a more businesslike approach to running the postal system. It followed a corporate model by

creating an 11-member Board of Governors with nine Governors appointed by the President with the advice and consent of the Senate. The board appoints the Postmaster General and together they appoint the Deputy Postmaster General, the 11th member of the board. The PRA changed the postal system in many other ways:

<u>Finances:</u> Gave the Postal Service the authority to operate on its own revenues; authorized the borrowing of funds from private financial markets in cooperation with the Treasury Department; required the Postal Service to break even over time; and phased down the public service subsidy, which ended in 1983.

<u>Ratemaking:</u> Created an independent Postal Rate Commission to recommend postal rates and classifications proposed by the Governors; gave the Governors the final decision on rates; and required that rates for each class of mail cover direct and indirect costs attributable to that class plus a proportion of USPS institutional costs.

<u>Personnel/Labor Relations:</u> Authorized collective bargaining between the Postal Service and employee unions on wages and working conditions; provided for consultation with management associations; protected the rights of employees to join a labor organization; provided pay comparability for postal employees with the private sector and broadened career opportunities; and prohibited political recommendations for postal appointments.

<u>Letter Monopoly/Universal Delivery:</u> Gave the Postal Service a limited monopoly on letter mail delivery to protect every American's right to universal service at uniform prices; directed the Postal Service to provide equal service to every citizen and to maintain small post offices that are not profitable; and provided preferred (lower) postage rates for not-for-profit organizations, local newspapers and others.

Automation and ZIP+4

In the quarter century since the passage of the Postal Reorganization Act, the Postal Service has made large capital investments to upgrade equipment, building and vehicles. Mechanization of mail processing has expanded and automation of processing has resulted in cost savings in conjunction with the ZIP+4 Code, an expanded ZIP Code that allows automated sortation to individual firms, buildings and streets. Pay and benefits of postal craft employees have achieved parity with the best-compensated private sector employees.

The Postal Service — while facing increasing competition in the communications business — remains a massive operation. It is the 12th largest corporation in the nation. In 1995, postal revenue of \$54 billion was more than Coca-Cola, Xerox, McDonald's and Walt Disney combined.

Delivering more than 40 percent of the world's mail, American postal employees are the most productive in the world, handling an average of 242,918 pieces of mail per employee. The next highest nations are Japan (169,834), Australia (115,606) and Switzerland (106,020). And postage rates in the United States are among the lowest in western industrialized nations. The 32-cent price of a First-Class Mail stamp is less than half of the rate in Germany (70 cents) and Japan (79 cents), based on prevailing exchange rates in mid-October 1995.

25TH ANNIVERSARY OF THE POSTAL SERVICE

Messages

- Postal employees are the organization's most important asset. They are a committed, talented and hardworking workforce who help make the Postal Service a major player in America's communications business.
- Postal employees personify traditional, positive American values. They are dependable, trustworthy and valued citizens, taxpayers and neighbors in thousands of cities and communities across America.
- Postal employees serve their communities and those in need. They deliver a vital service to their customers six days a week that is safe, secure and reliable.
- The Postal Service is the nation's most diverse organization, creating employment opportunities for its 753,000 career employees. Its Diversity Development function promotes an environment that recognizes and capitalizes on the strengths of individual differences and uniqueness.
- The Postal Service takes a national and community role in preserving a better environment and developing preventive measures to reduce work-place violence. It has launched a leadership awareness program for managers, postmasters, supervisors and local union officials to help understand and identify situations that pose risk, and to explain the available resources and strategies.
- Postal employees volunteer their time and talent in a variety of ways to improve community life for all Americans. The work of our many "heroes and hard workers" spans an enormous range, from volunteer firefighters and emergency medical technicians to academic tutors and counselors for youth and drug rehabilitation. They donate to the United Way, collect annually for local food drives and walk for the March of Dimes. They contribute millions to the Combined Federal Campaign. They're involved in the Carrier Alert and WEE Deliver Programs keeping a watchful eye on senior citizens, and helping elementary school students learn how to read and write. They are ordinary people doing extraordinary things to help other people.

PLANNING YOUR PROGRAM

Consider the following when planning an event to celebrate the 25th Anniversary of the Postal Service and the Postal Reorganization Act:

Event Ideas

- At your local event, stage the traditional "Happy Birthday" song and blow out candles as a photo opportunity for employee communications or the news media.
- Arrange for the highest ranking postal official attending the event to make a brief speech.
- Arrange for the mayor to issue a proclamation (see sample proclamation on page 21).
- Present certificates to employees who have 50 years or more with the Postal Service only. (Corporate Relations at Headquarters will provide these certificates.) Also present 25-year service pins to employees who have been with the Postal Service since 1971 (check with your District Human Resources Manager for distribution of pins).
- Set up a viewing area for a postal history video (video included in kit). Run the video continuously.
- Host an open house of your facility.
- In small communities, plan a photo opportunity of customers with their letter carriers. Take a Polaroid shot and hang pictures in a lobby display with the heading "25 Years of Serving You."
- Use retired postal employees as official greeters, circulating in the lobby to say "Thanks for coming," and handing out giveaways related to the 25th anniversary.
- Prepare a local history of the Postal Service in your community. Show progress over the past 25 years. Provide as a handout at the event and also send to local media in your news release.
- Choose four or five local employees who are active in the community. Position them with this theme: "We do more than deliver your mail."
- Place an ad in the local newspaper or on television featuring your post office open house, reception, lobby display, daily programs, etc.
- Re-run the "Postal Notes" ad in the local newspaper. Make a lobby display of the series of Postal Notes ads. (A "Postal Notes" ad will run in major newspapers across the country the week of June 24.)

Think 25!

Beginning June 7 start a 25-day countdown of events. (Activities listed below are in no particular order.) The day's activity can be publicized in advance or displayed on a poster in the lobby showing the events planned.

- Sponsor an essay or poster contest for local school children. Give a prize to the winners. Children could design a stamp.
- Magic "25" Day. Give stamp pins to customers showing proof of age 25, married for 25 years or who have a number "25" in mailing address, etc.
- The first 25 customers on a given day receive a free stamp.
- Open the office 25 minutes earlier or close the office 25 minutes later.
- Present awards to employees with 25-year perfect safety records.
- Ribbon/Button Day. Employees wear ribbons/buttons depicting "We deliver 25 years for you," etc.
- Present awards to employees with 2,500 accumulated sick leave hours.
- Recognize local agencies, e.g., the fire and police departments and the Red Cross, for their support of the Postal Service.
- Host Customer Appreciation Day (perhaps June 25). Refreshments should be available to customers.
- Carrier/Clerk Awareness Day. Designated carriers/clerks greet customers in the lobby for 25 minutes each.
- Box Customer Day. Show appreciation to customers who have had a post office box for 25 years.
- June 14, Flag Day. Buy small flags for posting on letter carrier vehicles. Involve school children/scout organizations in a flag-raising ceremony.
- Retiree Day. Honor past postmasters and other retired employees living in your community.
- Badge Day. Window clerks wear a ribbon: "Ask me about July 1!"
- Disabilities Recognition Day. Recognize employees/customers with disabilities as outstanding citizens of the community (e.g., Special Olympic winners, volunteerism honorees).
- Meet the Postmaster Day. Postmaster spends one day in the lobby, greeting people. Involve a local school in selecting a student to be "postmaster for the day." Serve refreshments.
- Dog Bite Awareness Week. This national campaign will be in June. Educate the public on dog bite prevention. Have letter carriers visit schools to talk to children.
- Trivia Contest. Educate the community about the Postal Service. Offer a trivia question about the Postal Service on each of the 25 days. Draw a name each day from the participants with the correct answer. On the final day of the contest draw a name from the 25 daily winners for a prize to go to the overall winner.
- Make the offer: "Buy 25 stamps, get one free."

■ Small Business Day. June is "Small Business Month." Have Postal Business Centers host open houses or display Postal Service publications in lobbies. Invite local businesspersons to meet the postmaster.

■ Silver Anniversary Day. Decorate the post office lobby in silver colors.

These are just a few examples of what you can do to prepare for the 25th Anniversary celebration. You can probably think of a hundred more ideas to help celebrate the anniversary. Have fun!

JULY 1, 1996 — Anniversary Day

Every post office in the country is encouraged to plan an event, big or small, on this day to commemorate the 25th anniversary of the Postal Service under the Postal Reorganization Act. Here are some suggestions:

- Arrange for a cake decorated in honor of the Postal Service's 25th anniversary to be presented to a local television personality on his/her program on the morning of July 1, 1996.
- If you have planned an event (e.g., open house, breakfast with civic leaders, customer appreciation day), you may wish to use some of the ideas listed elsewhere in this kit.
- Make available to the public a special 25th anniversary pictorial cancellation. Camera-ready artwork is available upon request (see instructions in this Postal Bulletin).

CHECKLIST: The 25th Anniversary Planning Committee

The following checklist is provided for your convenience. Omit all items that do not pertain to the kind of event you are planning:

■ Form a planning committee. It is imperative that leadership and direction come from an appointed chairperson, who will report directly to the installation head. The selected person should be able to draw together the necessary resources to plan and conduct a successful event.

The committee is responsible for executing a plan of action, including, but not limited to, the following areas:

- Preparing a master written checklist of everything that needs to be done or produced, the due date, who's responsible, etc., and keeping it up-to-date.
- Not overextending your resources. Reviewing the event's budget carefully.
- Making a list of the services, people and materials you'll need for the event.
- Planning events leading up to the July 1, 1996 Anniversary Day, and making arrangements for an event on July 1.
- Being responsible for purchasing anniversary cake(s) for the events.
- Extending special invitations to various individuals and groups, such as the mayor, civic leaders, and key mailers, to participate in programs, and following up on their acceptance. Being responsible for the printing of invitations, programs, banners, balloons and fliers, for decorating, selecting souvenirs, proclamations, providing entertainment, and for selecting an event site.

- Involving employees from all levels in planning. Management associations and employee unions are to be informed and invited to participate in the event.
- Making arrangements for parking and establishing liaisons as necessary with local law enforcement agencies; producing signs to direct parking; planning an alternate parking area for employees.
- Planning for refreshments; posting trash receptacles.
- Arranging for first aid (volunteers from the local fire department, public health office).
- Informing employees of the event and giving them an opportunity to volunteer their services. You might have a singer or musician in your office who would like to perform.
- Checking with local schools for student entertainment.
- Checking on the condition of the American and postal flags. Are they in good condition?
- Always having a contingency plan. If attendance turns out to be much greater than expected, how will you handle the overflow? If it's much lower, what will you do with leftover refreshments, etc.?
- Remembering that nonexempt employees are on-the-clock for the time they spend helping to plan and conduct an event.
- Designating one person as publicity person. This person is responsible for providing publicity of the events to employees. A news release should be sent to the local news media announcing the program. (The Area Corporate Relations Center can assist you with contacting the media.)

If Hosting an Open House

- Determine how many people are expected to attend.
- Be responsible for organizing visitor tours through work areas while ensuring security of the mail, safety and crowd control.
- Notify all supervisors of the tour route.
- Select tour guides and assign them duties.
- Rehearse with the tour guides their commentary on points of interest in your facility and conduct a dry-run of the tour.

Adapt these guidelines to individual cases. Each postmaster should be guided mainly by knowledge of the local situation.

After the Event

- Have "thank you" notes been sent to each committee member?
- Has the entire workforce been commended?
- Have special "thank you" letters been sent to persons outside the Postal Service who contributed to the success of the event?
- Have all pending questions, suggestions and comments from the visitors been answered or acknowledged in writing?

Olympic Logo (Olympic Rings) — Removal Reminder

As the Summer Olympic Games in Atlanta, Georgia, draw closer, heightened scrutiny is given to the improper use of the protected trademarks by sponsors as well as the Olympic committees. It is imperative that immediate attention be given to the removal of all unauthorized displays of the Olympic logo.

General Counsel at Headquarters continues to receive frequent contacts from the United States Olympic Committee concerning the unauthorized display and use of the Olympic logo. General Counsel has recommended that we reissue this reminder notice, which has appeared in *Postal Bulletin* 21883 (12-22-94) and 21908 (12-7-95).

All field managers are reminded that the U.S. Postal Service is no longer an Olympic corporate sponsor. As such, it is not licensed to display the Olympic logo (inclusive of Olympic marks, symbols, or terminology) on any of its equipment, buildings, packaging, or stationery items.

All offices must immediately survey their areas of responsibility for these logos and arrange for their removal. Likely locations of these logos include collection boxes, postal vehicles, entry doors to both post office box and retail lobbies, and display posters. Terminate immediately all use of stationery and packaging items (letterhead, envelopes, pens, pins, etc.) displaying the Olympic logo, with particular emphasis on Priority and Express Mail envelopes, which continue to surface as an issue. Any existing envelopes displaying the Olympic logo may be used only if the logo is taped over in such a manner as to completely obscure it. Otherwise, they should be destroyed, as their continued use by the Postal Service may be violation of the law and previous agreements.





2.6 Customs Declarations

Any mailpiece weighing more than 16 ounces that is addressed to an APO or FPO ZIP Code must bear

Form 2976 and must be presented to an employee at a post office or as designated by the postmaster. Certain destination APO and FPO addresses require Form 2976-A, as shown in the chart *Conditions Applied to Mail Addressed to Military Post Offices Overseas*, published in the *Postal Bulletin*. Unless the destination ZIP Code has a customs declaration form requirement in the chart, any known mailer (see *International Mail Manual* (IMM) 123.62) presenting bulk mailings that are declared on a postage statement is not required to use customs forms. IMM 123 contains procedures for completing the forms. Official mail going to, from, or between APO or FPO ZIP Codes is exempt from the requirements of this section unless customs declarations are necessary for customs treatment as indicated in the chart.

New Triangular Tubes Designed for Express and Priority Mail

The new Priority Mail tube (PSIN 01098, PSN 8115-03-000-7009) will also be used to send Express Mail. One side of this triangular tube contains space and instructions for an Express Mail label (see companion article on page 2).

The new tube measures 38" x 6", which is two inches longer than the existing round Express Mail tube. As current supplies are exhausted, the new triangular tube will be used for both Express Mail and Priority Mail.

Samples of this new product will be sent to Express Mail managers and plant managers on May 27, and will be available in postal retail outlets beginning June 17.

Centralized Meter Licensing System Forms Implementation

One of the current initiatives in the administration of the postage meter program is the Centralized Meter Licensing System (CMLS). This consolidates nationwide the issuance of all meter licenses through the National Customer Support Center (NCSC) in Memphis. Licenses will no longer be issued by individual post offices. CMLS will offer greater efficiencies for licensing as well as providing for a detailed database of licensee information. In addition, it will track meter population and meter movement based on meter manufacturer transactions, including all installations, withdrawals, and replacements. National implementation of CMLS is scheduled for August 1, 1996. A comprehensive national CMLS awareness effort will take place prior to national implementation.

Two forms have been developed to support CMLS. The first is a revised Form 3601-A, *Application or Update for a License to Lease and Use Postage Meters* (May 1996). Secondly, a new form for reflecting meter activity has been developed to replace the individual forms currently used by the meter manufacturers. The new form is Form 3601-C, *Postage Meter Activity Report* (May 1996). Both forms were recently pilot tested in Phoenix and Baltimore and are scheduled for national implementation on June 6, 1996. The forms are being implemented earlier than CMLS in order to give post offices some experience with their use. As a result, there are some differences in form processing during the interim period of June 6 through July 31.

Interim Period Processing

Customers may obtain the new application (Form 3601-A) from the licensing post office or from their manufacturer representative. The completed application is presented to the licensing post office when a meter is to be installed. At the same time, the manufacturer's representative submits a completed *Postage Meter Activity Report* (Form 3601-C). The postal clerk assigns a license number according to existing procedures and records the number on the license (old form) given to the customer. The clerk records the license number in block B3 of Form 3601-C. Both the application and the activity report are then forwarded to the district Meter Accounting and Tracking System (MATS) coordinator for input into MATS. After the MATS coordinator completes the input function, the application is forwarded to the following address at the NCSC:

CENTRALIZED METER LICENSING SYSTEM NATIONAL CUSTOMER SUPPORT CENTER US POSTAL SERVICE 6060 PRIMACY PKY STE 201 MEMPHIS TN 38188-0001 If a customer submits the previous edition of Form 3601-A during the interim period, the application is to be accepted and processed as above.

Processing Effective August 1

With national implementation of CMLS, the customer has three options for submitting a completed application on Form 3601-A:

- To the manufacturer's representative. The application is subsequently transmitted electronically to the NCSC by the manufacturer for issuance of the license.
- To the post office where metered mail will be entered.
 The post office does not issue a license but forwards the application to the NCSC at the address noted above.
- 3. Directly to the NCSC at the address noted above.

When meter activity occurs, the manufacturer's representative submits a completed activity report (Form 3601-C) to the post office, which then forwards the form to the district MATS coordinator. Simultaneously, the manufacturer submits a copy electronically to the NCSC.

Form Distribution

Meter manufacturers will be issued a supply of the new forms. Post offices will receive a limited supply of forms to be used during the interim period as stated above. After July 1, 1996, Form 3601-A and Form 3601-C may be ordered from the material distribution centers using Form 7380, MDC Supply Requisition. See pages 33–34 for samples of the new forms.

Meter Service Fees for On-Site Meter Settings, Examinations, Check-In, and Check-Out

Several deficiencies relating to on-site meter service fees have been uncovered by the Inspection Service. These deficiencies include the failure to charge and collect the correct revenue due for the on-site service. The following information should clarify the proper application and collection of on-site meter service fees.

The on-site meter setting program allows USPS employees to set or examine meters at the manufacturer's branch office, direct distribution centers, or the licensee's place of business. The program also provides for checking meters into or out of service.

A fee is charged for each meter that is set, examined at a licensee's place of business, or checked into or out of service at a manufacturer's office, unless a USPS employee (qualified to set meters) is regularly assigned to the licensee's location for other postal administrative duties. The onsite service is provided to the licensees on a scheduled or an unscheduled basis. The fee structure is given in Domestic Mail Manual (DMM) R900.10.0:

Meter Service

Scheduled basis	\$ 27.50	\$ 3.25	\$ 7.50		
Unscheduled basis	31.00	3.25	7.50		

If a postal unit provides USPS employees to a licensee or manufacturer on a *scheduled basis* to set or examine meters, the fee for the first meter for each employee is \$27.50, and \$3.25 for each additional meter thereafter. If a postal unit provides employees on an *unscheduled basis* to set or examine meters, the fee for the first meter for each employee is \$31.00, and \$3.25 for each additional meter. In addition to the setting and examination fees, a surcharge of \$7.50 is collected for each meter that is checked into or out of service.

Example 1:

Three on-site employees are *scheduled* to perform meter settings or examinations for a licensee or manufacturer on a total of 11 postage meters. Employee #1 checks one meter, employee #2 checks two meters, and employee #3 checks eight meters. The fees charged would be:

An additional \$7.50 is charged for any meter checked into or out of service.

Example 2:

If the three on-site employees are performing the same meter checks on an *unscheduled* basis, the fees charged would be:

An additional \$7.50 is charged for any meter checked into or out of service.

Each postmaster is requested to review these service fees and their application with all employees involved with the on-site meter setting program to ensure that all applicable postal revenues are being properly applied and collected.

The tables below outline these conditions by APO/FPO ZIP Code through the use of footnoted mailing restriction codes, which appear on the page following Table 2.

Acceptance clerks should use these tables with the

integrated retail terminal (IRT) to determine whether an APO/FPO ZIP Code is active and which conditions of mailing apply. For Express Mail Military Service (EMMS) availability, refer to Handbook PO-514, *Express Mail Military Service*, and the local EMMS directory.

- A. Securities, currency, or precious metals in their raw, unmanufactured state are prohibited. Official shipments are exempt from this restriction.
- B. Form 2966-A is required. Prepaid mail from a contractor addressed to a military organization for official use need not bear a customs declaration, but must be endorsed "Contents for Official Use-Exempt from Customs" Requirement." Official mail from government agencies does not require a customs declaration or an exemption endorsement.
- B1. Form 2966-B is required. Articles are liable for customs duty and/or purchase tax unless they are bona fide gifts intended for use by military personnel or their dependents. When the contents of a parcel meet these requirements, the mailer must endorse the customs form, "Certified to be a bona fide gift, personal effects, or items for personal use of military personnel and dependents," under the heading, Description of Contents.
- B2. Form 2966-A is required except on official mail, which does not require customs declaration or exemption endorsement. The AAFES will furnish a computer listing of all items mailed from its activities to Philippine APOs. Other mail order companies must either use Form 2966-A on each item or provide computer lists. Computer listings must include a description of the items, the dollar values of the items, and complete address including the PSC box number and APO of the addressee, the date of mailing, the insurance registry number, if applicable, and the serial number of any item over \$25 in value and any electrical item with a plug over \$15 in value.
- B3. Form 2966-A is required for mailing between MPOs. Prepaid mail from contractors addressed to a military organization for official use need not bear a customs declaration, but must be endorsed "Contents for Official Use-Exempt from Customs Requirement." Official mail from government agencies does not require a customs declaration or exemption endorsement.
- B4. Form 2976 or 2976-A is required for all mail weighing over 16 ounces. Prepaid mail from contractors addressed to a military organization for official use need not bear customs declaration, but must be endorsed, "Contents for Official Use—Exempt from Customs Requirement." Official mail from government agencies does not require customs declaration or exemption endorsement.
 - C. Cigarettes and other tobacco products are prohibited.
- C1. Obscene articles, prints, paintings, cards, films, videotapes, etc., and horror comics and matrices are prohibited.
 - D. Coffee is prohibited.
- E1. Medicines or vaccines not conforming to French laws are prohibited.
- E2. Any matter containing religious materials contrary to Islamic faith or depicting nude or seminude persons, pornographic or sexual items, or nonauthorized political materials is prohibited.
- E3. Radio transceivers, cordless telephones, global positioning systems, scanners, base stations, and hand-held transmitters are prohibited.
- F. Firearms of any type are prohibited in all classes of mail. See definitions of firearms in DMM C022.1.1. This restriction does not apply to firearms mailed to or by official U.S. government agencies.
- F1. Privately owned weapons addressed to an individual are prohibited in any class of mail.

- F2. Importation of firearms is restricted to one shotgun and one single shot .22 caliber rifle per individual.
 - G. Only First-Class letters, second- and third-class mail are authorized.
- H. Meats, including preserved meats, whether hermetically sealed or not, are prohibited.
 - H1. Pork or pork by-products are prohibited.
- I. Mail of all classes must fit in a mail sack. Mail may not exceed the following dimensions:

This restriction does not apply to registered mail and official government mail marked MOM.

- K. Mail that includes in the address the words, "Dependent Mail Section," may consist only of letter mail, newspapers, magazines, and books. No parcel of any class containing any other matter may be mailed to the Dependent Mail section. This restriction does not apply if the address does not include the words "Dependent Mail Section."
 - L. All official mail is prohibited.
 - M. Fruits, animals, and living plants are prohibited.
 - N. Registered mail is prohibited.
- O. Personal mail addressed to vessels using this number is limited to unregistered First-Class Mail and certified mail. Other classes of mail are prohibited
 - P. APO is used for the receipt and dispatch of official mail only.
- Q. Mail may not exceed 66 pounds, and size is limited to 42 inches maximum length and 72 inches maximum length and girth combined.
- R. All alcoholic beverages, including those mailable under DMM C021, are prohibited.
- R1. Materials used in the production of alcoholic beverages (i.e., distilling material, hops, malts, yeast, etc.) are prohibited.
- T. Mailings of case lots of food and supplemental household shipments must be approved by the sender's parent agency prior to mailing.
- U. Parcels must weigh less than 16 ounces when addressed to Box R. This restriction does not apply to mail endorsed "Free Matter for the Blind or Handicapped.'
- U1. Mail is limited to First-Class Mail weighing 11 ounces or less when addressed to Box R. This restriction does not apply to mail endorsed "Free Matter for the Blind or Handicapped." Videotapes are prohibited when addressed to Box R, regardless of weight.
 - U2. Mail is limited to First-Class letters only when addressed to Box R.
- U3. Mail is limited to First-Class correspondence (including voice and video cassettes), newspapers, magazines, photographs, not exceeding 16 ounces, when addressed to Box R.
- W. Meat products, such as dried beef, salami, and sausage, may be mailed, provided they remain in their original, hermetically sealed packages and bear USDA certification. Other meats, bones, skin, hair, feathers, horns or hoofs of hoofed animals, wool samples, tobacco leaves, including chewing and pipe tobacco, snuff, cigars, and cigarettes, or obscene material, including obscene drawings, photographs, films, and carvings, are prohibited. Exception: 200 grams of tobacco per parcel are permitted duty free.
- X. Personal mail is limited to First-Class Mail (to include audio cassettes and voice tapes) weighing 11 ounces or less. This limitation does not apply to
- Y. Mail is limited to First-Class and Priority Mail only. All second-class, third-class, and fourth-class mail (including SAM and PAL) are not authorized. This restriction also applies to official mail.

IMM REVISION

New International Mail Customs Forms

Effective September 1, 1996, the Postal Service is adopting new customs forms and acceptance procedures for international and military mail. The new forms and regulations detailed below will deter mailers from using the mails to send, knowingly or unknowingly, dangerous goods or explosives and will comply with heightened stricter security measures as directed by the Federal Aviation Administration and the Universal Postal Union. The changes were published in the *Federal Register* on September 27, 1995 (60 FR 49755–49758). Minor editorial changes have been made to the original text to clarify instructions.

The key aspects of the changes are: (1) face-to-face interaction between the mailer and a postal employee; (2) the completion of a document (customs form) containing the mailer's name, address, and signature; (3) the statement on the form regarding the safety of the contents and that the mail is subject to "security controls"; and (4) retention of one copy of the customs declaration form until such time as delivery is completed.

The new Forms 2976, 2976-A, and 2976-E (envelope) shown on pages 60–61 will replace the following international customs forms:

- Form 2976, Customs Douane C1 (green label).
- Form 2976-A, Customs Declaration.
- Form 2966-A, *Parcel Post Customs Declaration* (white single adhesive form).
- Form 2966-B, *Parcel Post Customs and Dispatch Note* (multiple part form).
- Form 2966-E, Plastic envelope.

Date of Customs Forms

The new forms have a May 1996 edition date; however, use of the new form will be phased in over the next 3 months. Until September 1, 1996, the 1995 editions of the customs forms may also be used. This phase-in period will allow post offices to order initial supplies of the new forms and become familiar with the requirements. Postmasters should inform all customers of the new requirements and encourage them to comply with these changes as soon as possible.

Availability of Forms

The new Forms 2976, 2976-A, and 2976-E are available at the material distribution centers. To ensure that sufficient forms are in the pipeline, post offices should order no more than a 2-month supply using Form 7380, *MDC Supply Requisition*. Although Form 2976-A and Form 2976-E are numbered separately, they must be used together.

Upon receipt of the new forms or after September 1, 1996, discard all previous editions of Forms 2976, 2976-A, 2966-A, 2966-B, and 2966-E. Old stock must not be returned to the MDC. Effective September 1, 1996, only the May 1996 edition of Forms 2976, 2976-A, and 2976-E may be used on international and military mail as specified in *International Mail Manual* (IMM) 123.

IMM Issue 17 will include these changes. IMM Issue 16 is revised as follows:

International Mail Manual (IMM)

Chapter 1 International Mail Services

123 Customs Forms

123.1 General

Only two customs declaration forms are used, as required under 123.6, for international mail: Form 2976, *Customs CN 22* (old C 1); and Form 2976-A, *Customs Declaration and Dispatch Note CP 72* (old C 2/CP 3/CP 2). Form 2976-E, *Customs Declaration Envelope CP 91*, is used with Form 2976-A for parcel post packages. Only forms dated May 1996 or later may be used.

123.2 Availability

Customs declaration forms are available without charge at post offices. Upon request, mailers may receive a reasonable supply for mail preparation.

123.3 Privately Printed Forms

If authorized, mailers may privately print Forms 2976 and 2976-A. Privately printed forms must be identical in size, design, and color to the Postal Service forms, and each form must contain a unique code 128 barcode number that can be read by Postal Service equipment. Form specifications may be obtained from the Manager, International Pricing, Costing and Classification, International Business Unit, U.S. Postal Service, 475 L'Enfant Plaza SW, IBU 370, Washington DC 20260-6500. For authorization, mailers must submit at least two preproduction samples to the Manager, International Pricing, Costing and Classification, at the above address, for review and approval. If three or more items are presented at one time, the mailer may omit printing the post office copy of Forms 2976 and 2976-A if a manifest of the items is provided. The manifest must contain the same mailer's certification statement and edition date printed on the Postal Service forms. Entries on the manifest must be typewritten or printed in ink or by ballpoint pen. The manifest option must be indicated at the time that the mailer requests to produce privately printed forms.

123.4 Nonpostal Forms

Certain items must bear one or more of the forms required by the nonpostal export regulations described in chapter 5.

123.5 Place of Mailing

Items requiring customs declaration forms may be mailed only by presenting the items and completed forms to an employee at a post office or as designated by the postmaster. Express Mail items paid by corporate account, however, may be deposited into Express Mail collection boxes. All other items requiring customs forms that are found in collection boxes or not presented to a postal acceptance employee are returned to the sender for proper mailing and acceptance.

123.6 Required Usage

123.61 Conditions

Customs declaration Forms 2976 or 2976-A and 2976-E (envelope) must be used as shown in Exhibit 123.61.

123.62 Known Mailers

Known mailers may be exempt from providing customs declaration forms as required in 123.61 on nondutiable letters, letter packages, and printed matter weighing more than 16 ounces. A known mailer is any holder of an advance deposit account, a customer billing account or a customer identification number for international mailing programs such as International Surface Air Lift, International Priority Airmail, Valuepost/CANADA, and International Parcel Consignment Service, who mails regularly and is known by the acceptance clerk. A known mailer must complete the declaration on the postage statement, certifying that all items in the mailing contain no dangerous material.

Note: Although an exemption may apply to known mailers for nondutiable items and printed matter weighing more than 16 ounces, all mailers (known mailers or unknown mailers) must complete the necessary customs form when sending dutiable items or merchandise. A customs form may also be required if specified by the country of destination.

123.63 Additional Security Controls

When the chief postal inspector determines that a unique, credible threat exists, the Postal Service may require a mailer to provide photo-identification at the time of mailing. The signature on the identification must match the signature on the customs declaration form.

123.7 Completing Customs Forms

123.71 Form 2976, Customs CN 22 (Green Label)

123.711 Preparation by Sender

A sender completes Form 2976, Customs CN 22, by:

- a. Providing a complete description of each article in the item, even if it contains commercial samples, documents, gifts, or merchandise. General descriptions such as "food," "medicine," "gifts," or "clothing" are not acceptable. The description must be in English, although an interline translation in another language is permitted.
- b. Stating the exact quantity of each article in the item.
- c. Declaring the value, in U.S. dollars, of each article in the item. The sender may declare that the contents have no value (declaring no value does not exempt the item from customs examination or charges in the destination country).
- d. Showing the total weight of the item, if known.
- Indicating in the appropriate check box on the form whether the item contains gifts, merchandise, or commercial samples. If not, the sender does not check these boxes.
- Entering his or her full name and return address in the blocks indicated.
- g. Signing and dating the form in the blocks indicated on both parts of the form. The sender's signature certifies that all entries are correct and that the item contains no dangerous material prohibited by postal regulations.
- h. Affixing the form to the address side of the item and presenting it for mailing.

123.712 Acceptance by Postal Employee

The postal employee accepts the item for mailing by:

a. Instructing the sender how to complete the customs declaration form, as required, legibly and accurately. Failure to complete the form properly can delay delivery of the item or inconvenience the addressee. Moreover, a false, misleading, or incomplete declaration can result either in the seizure or return of the item or in criminal or civil penalties. The U.S. Postal Service assumes no responsibility for the accuracy of information that the sender enters on the form.

- b. Verifying that the required information is entered on the form and that the sender has signed both parts (the part affixed to the item and the part separated for postal records).
- Entering the weight of the item on the form, if not already done.
- d. Removing the post office copy and retaining it in the retail unit for 30 days.

123.72 Form 2976-A, Customs Declaration and Dispatch Note CP 71

123.721 Preparation by Sender

A sender completes Form 2976-A, Customs Declaration and Dispatch Note CP 72, by:

- a. Providing the names and addresses of the sender and addressee.
- b. Providing information about the contents of the parcel or item. (If there is insufficient space on the customs declaration form to list all contents of the parcel or item, a second form is used to continue listing the contents. The first form must be annotated to indicate two forms. Both forms are placed into Form 2976-E (envelope).) The sender lists this information by:
 - (1) Providing a complete description of each article in the parcel or item, even if it contains commercial samples, documents, gifts, or merchandise. General descriptions such as "food," "medicine," "gifts," or "clothing" are not acceptable. The description must be in English, although an interline translation in another language is permitted.
 - (2) Showing the exact quantity of each article in the parcel or item.
 - (3) Declaring the value, in U.S. dollars, of each article in the parcel or item. The sender may declare that the contents have no value (declaring no value does not exempt the parcel or item from customs examination or charges in the destination country).
 - (4) Showing the net weight of each article in the parcel or item.
- c. Indicating in the appropriate check box on the form whether the parcel or item contains commercial samples, documents, gifts, or merchandise. If not, the sender does not check these boxes.
- d. For parcel post only, providing disposal instructions in the event that a parcel cannot be delivered. The sender checks the appropriate box on the form to indicate whether the parcel is to be returned, treated as abandoned, or forwarded to an alternate address. (Undeliverable parcels returned to the sender are subject to collection on delivery of return postage

and any other charge assessed by the foreign postal authorities. The sender must check the box "Abandon" for any parcel for which the sender is unwilling to pay return postage.)

- e. Signing and dating the form in the block indicated.
 The sender's signature certifies that all entries are correct and that the parcel or item contains no dangerous material prohibited by postal regulations.
- f. Presenting the parcel post package or item for mailing at a post office and affixing Form 2976-A according to the class of mail, as follows:
 - (1) For parcel post, the sender must not place Form 2976-A inside Form 2976-E (envelope) before the postal acceptance employee completes the required information described in 123.722. After the postal employee completes Form 2976-A, the sender places the form inside Form 2976-E and affixes it to the outside of the parcel.
 - (2) For an item other than parcel post (that is, an LC or AO item) valued at \$400 or more, the sender places Form 2976-A inside the item before the postal employee accepts the item. If the sender does not want to show on the outside wrapper the contents of the LC or AO item, the sender affixes the top part of Form 2976, Customs CN 22, to the wrapper and completes Form 2976-A and encloses it in the item.

123.722 Acceptance by Postal Employee

When Form 2976-A is enclosed in an LC or AO item, the postal acceptance employee does not verify or complete the entries on the form as described below for parcel post. For a parcel post package, the postal employee accepts the parcel for mailing by:

a. Instructing the sender how to complete the customs declaration form, as required, legibly and accurately. Failure to complete the form properly can delay delivery of the mail or inconvenience the addressee. Moreover, a false, misleading, or incomplete declaration can result either in the seizure or return of the parcel or item or in criminal or civil penalties. The U.S. Postal Service assumes no responsibility for the accuracy of information that the sender enters on the form.

- b. Verifying that the required information is entered on the form and that the sender has signed the declaration.
- c. Completing an insurance receipt and affixing the insured number label to the package, if the contents are to be insured. The postal employee enters on the form the insured number and, in U.S. dollars and SDRs, the insured amount.
- d. Weighing the parcel and entering on the form the gross weight and the amount of postage.
- e. Postmarking copy 3, Dispatch Note, in the appropriate place.
- Removing the post office copy and retaining it at the retail unit for 30 days.
- g. Returning the form set to the sender for affixing to the parcel. Form 2976-E (envelope) must be used with Form 2976-A.

123.73 Form 2976-E (envelope) CP 91

Form 2976-E (envelope) is a transparent plastic envelope designed for carriage of Form 2976-A form set for parcel post. Upon completion of the forms, the sender inserts the form set into the envelope and affixes it to the outside of the parcel.

Chapter 2 Conditions for Mailing

242.3 Mailing Locations

242.31 General

Except for Express Mail items paid by corporate account, items requiring customs declaration forms may be mailed only by presenting the items and completed forms to an employee at a post office or as designated by the postmaster. Such items may not be deposited into street collection boxes or post office lobby drops. Items not requiring customs forms and fully prepaid with postage stamps or meter postage may be deposited into collection boxes or lobby drops. (See Exhibit 123.61 for a summary of items requiring customs forms.)

Pictorial Cancellations Announcement 96-11

As a community service, the Postal Service offers pictorial cancellations to commemorate local events celebrated in communities throughout the nation. A list of upcoming events for which pictorial cancellations are authorized appears below. If available, the sponsor of the pictorial cancellation appears in italics under the date. Also provided, as space permits, are illustrations of those cancellations that were reproducible and available at press time.

People attending these local events may obtain the cancellation in person at the temporary post office station established there. Those who cannot attend the event, but who wish to obtain the cancellation, may submit a mail order request. Pictorial cancellations are available only for the dates indicated, and requests must be postmarked no later than 30 days following the requested pictorial cancellation date.

All requests must include a stamped envelope or postcard bearing at least the minimum First-Class Mail

postage (32 cents per envelope or 20 cents per postcard). Items submitted for cancellation may not include postage issued after the date of the requested cancellation. Such items will be returned unserviced.

Customers wishing to obtain a cancellation should affix stamps to any envelope or postcard of their choice, address the envelope or postcard to themselves or others, insert a card of postcard thickness in envelopes for sturdiness, and tuck in the flap. Place the envelope or postcard in a larger envelope and address it to: PICTORIAL CANCELLATIONS, followed by the NAME OF THE STATION, ADDRESS, CITY, STATE, ZIP + 4 CODE, exactly as listed below (using all capitals and no punctuation, except the hyphen in the ZIP + 4 code).

After applying the pictorial cancellation, the Postal Service returns the envelope or postcard through the mail. Customers who want their serviced item returned under protected cover should include a larger, stamped, self-addressed envelope.

James Dean Commemorative Stamp (Legends of Hollywood Series)

The Postal Service will honor James Dean with the issuance of a 32-cent commemorative stamp (Item 4404), in a pane of 20, on June 24, 1996, in Burbank, California. The stamp goes on sale nationwide June 25. This is the second stamp to be issued in the Legends of Hollywood series.

Designed by Michael Deas of New Orleans, Louisiana, the stamp portrays Dean, based on an image from a photograph taken by Roy Schatt in 1954. Michael Deas also designed the Marilyn Monroe and Tennessee Williams stamps.

Actor James Dean was born on February 8, 1931, in Marion, Indiana. During his brief career, he quickly became a teen idol, as his work spoke for the youth of the 1950s. He starred in only three movies — *East of Eden* (1954), *Rebel Without a Cause* (1955), and *Giant* (1955) — before his untimely death in a car crash on September 30, 1955, near Cholame, California. Both *Rebel Without a Cause* and *Giant* were released after his death.

How to Order the First Day of Issue Postmark

All stamp distribution offices (SDOs) and stamp distribution networks (SDNs) will receive double their standard automatic distribution for a 20-stamps-per-pane issue,

rounded to the nearest master carton size (50,000 stamps). SDOs and SDNs will make one distribution to post offices equaling two times their standard automatic distribution using Form 3309, *Advice of Shipment/Stamp Invoice*, and Form 17, *Stamp Requisition*. SDOs and SDNs must not distribute stamps to post offices before June 17, 1996.

Philatelic Requirements

SDOs with authorized philatelic centers will receive automatic distributions of this stamp in six positions in the following quantities for subsequent distribution to each center:

Additional Supply

Post offices requiring additional stamps must requisition them from their designated SDO, using a separate Form 17, *Stamp Requisition*, or designated SDN, using a separate Form 17-S, *Stamp Distribution Network Stamp Requisition*. SDOs requiring additional stamps must order them from their designated APD, using a separate Form 17.

The New York, New York, Washington, D.C., Memphis, Tennessee, and Chicago, Illinois, accountable paper depositories (APDs) will receive 3,550,000 stamps for filling supplemental orders. The Denver, Colorado, and San Francisco, California, APDs will receive 3,600,000 stamps; the Kansas City, Missouri, SDN will receive 3,700,000 stamps; and the Dulles, Virginia, SDN will receive 3,000,000 stamps for filling supplemental orders.

Sales Policy

All post offices must acquire and maintain a supply of each new commemorative stamp as long as customer demand exists or until the stamp is officially withdrawn from sale, usually 1 year from the date of issue. If supplies run low, post offices must reorder additional quantities through their normal ordering procedures.

Migratory Waterfowl Survey — Duck Stamps

The Postal Service is again helping the Fish and Wildlife Service, Department of the Interior, conduct its annual survey to measure the harvest of migratory waterfowl during the coming hunting season. Not all post offices will participate in the survey, but certain randomly selected post offices, stations, and branches will.

The Department of the Interior sends the materials directly to the postmaster, or to the selected stations and branches of some larger post offices after notifying the postmaster. Only the selected units may distribute the Federal Duck Stamp Cards.

Each shipment includes:

- Federal Duck Stamp Cards for the hunter's name and address.
- 2. Instructions for window personnel.
- 3. Acknowledgment postcard (Fish and Wildlife Service Form M.S. 7).

Managers should:

- 1. Inform employees of survey instructions.
- 2. Acknowledge receipt of the materials using enclosed postcard (Fish and Wildlife Service Form M.S. 7).

Window personnel should:

- Give a Federal Duck Stamp Card to all purchasers of Migratory Bird Hunting and Conservation (duck) stamps, including collectors and nonhunters, at the time of purchase.
- Ask the customer to fill in the name and address portion and return the card to the window clerk for mailing. The customer detaches and keeps the stub (hunting diary) portion of the card to record daily hunting activity.
- 3. If customers purchase stamps for resale or for distribution to other hunters, give them one instruction sheet and a name and address card for each stamp. Ask them to request the actual stamp recipient to fill in, detach, and mail the business reply portion of the card without delay. Stamp collectors should receive only one card.

Customer participation is voluntary but essential to the survey's success. The cooperation of all postmasters, managers, and window personnel involved is appreciated.

STAMP DISTRIBUTION

Migratory Bird Hunting and Conservation Stamp, Item 3327

The \$15 Migratory Bird Hunting and Conservation stamp for the 1996–97 hunting season goes on sale in Washington, D.C., on June 27, 1996, and will remain on sale through June 30, 1997. The Department of the Interior formally issues the stamp at the National Postal Museum on June 27 and it goes on sale nationwide July 1.

Distribution

Post Offices

To allow postmasters to order the 1996–97 stamp in quantities closely corresponding to customer demand, the minimum ordering quantity is five stamps. However, postmasters should order full panes of 30 stamps when practical. Postmasters should review their records to determine the average number of Migratory Bird stamps previously sold and use this information to determine the appropriate number of the 1996–97 stamps to requisition, rounded up to multiples of five or 30 stamps.

Postmasters must immediately send a separate Form 17, Stamp Requisition, to their stamp distribution office (SDO) for enough Migratory Bird Hunting and Conservation stamps, Item 3327, to last until March 1, 1997. If the initial supply is exhausted before March 1, 1997, postmasters must requisition an additional supply. Postmasters with philatelic centers should order according to philatelic demand.

Stamp Distribution Offices

SDOs must review their inventory records for past issues and postmasters' requisitions for the 1995–96 Migratory Bird stamps to determine the quantity needed of the 1996–97 Migratory Bird stamps.

SDOs requiring these stamps in bulk quantities should requisition them from the Bureau of Engraving and Printing using Form 3356, *Stamp Requisition — Bulk Quantities*, using Item No. 3327. Order the stamps in quantities of 3,000; 6,000; 9,000; 12,000; 15,000; 30,000; 45,000; 60,000; and 75,000 stamps and in multiples of 75,000 to a maximum of 675,000 stamps per requisition.

SDOs requiring fewer than 3,000 stamps must send Form 17 to their accountable paper depository.

Hunting Regulations Pamphlets

The Department of the Interior does not automatically distribute pamphlets on hunting regulations because migratory game bird laws vary by state. Poster 3-124, Waterfowlers Attention (July 1992), indicates where to direct inquiries about hunting regulations of the state wildlife agency or local areas of the U.S. Fish and Wildlife Service.
